Watertown Historical Moving Plays: The Charles W. Lenox Experience Accessibility Information

General Information

As these tours take place in public facilities and on sidewalks, they are fully accessible to visitors who use wheelchairs or mobility devices. Our staff has reviewed the tour route for any obstructions or inaccessible pathways, and has described our findings below. Please be advised that this tour involves up to 60 minutes of walking and standing with minimal opportunities to sit down.

New Repertory Theatre is working with Ellice Patterson as an **Accessibility Consultant** on this production.

The actor will use a **microphone** so as to be well-heard by all during the outdoor experience. He will also wear a **clear mask or face shield** so that visitors will still have the opportunity to read lips.

The total route mileage is **0.5 miles**.

Each stop on the route has **benches** close by should visitors need to briefly rest.

Any **role play** involved in the tour is completely voluntary.

Accessible Parking/Drop-Off Loop

New Rep is working with the City of Watertown to reserve two dedicated accessible parking spots per tour, located close to the check-in area. **Exact location is pending confirmation from the City of Watertown as of 9/15/20.**

Alternatively, visitors who use wheelchairs or mobility devices can be dropped off at the check-in area on the one-way street connecting Galen and Pleasant Streets, near the Charles River Greenway.

The check-in area, drop-off area, and accessible parking area will all be indicated on a downloadable map. We will specify numbers/areas on the map once it is designed. In progress as of 9/15/20.

Tour Description

Visitors who use wheelchairs or mobility devices should please be aware of the following:

1st Stop: Watertown Square Delta

In order to reach the first stop on the route, the group will need to cross a short crosswalk. There is grass grounding at this stop, but sidewalks are nearby for those who prefer to stay on concrete.

2nd Stop: Lenox's Barbershop Site

To reach the second stop, the group will need to cross two short crosswalks from the Watertown Square Delta to the square in front of the Watertown Savings Bank.

3rd Stop: Watertown Free Public Library

There is brick grounding in front of the library.

4th Stop: Saltonstall Park and the Civil War Monument

There is gravel around the Civil War monument. A sidewalk to the right of the monument serves as a safe accessibility entrance. As this stop concludes the tour, patrons can be picked up from a one-way side street to the right of the monument.
